### **Fire**

Asst. Chief Irwin completed Shriner's Grant application for the Broselow Module complete refills x2 and a cyanokit. Total \$3840.

Trustee Moyer had conversations with Perry County 911 on April 4th, Jackson Township Trustee Tom Spohn April 4th and Junction City Fire Chief John Mason on April 5th. Chief Mason stated he had discussed the issues with Mayor Keister and Jackson Township Trustees and he was immediately removing Rushcreek Township Fire from their "run" card. Trustee Moyer asked on three separate occasions during the conversation if he was sure that was the approach he wanted to follow. Chief Mason indicated yes and wanted no further discussion. Tom Spohn was at our meeting representing Spohn Excavating but is also a Jackson Township Trustee. Tom stated he was told the problem was resolved at Junction City Fireman's Ball on April 12<sup>th</sup>. He had no further discussion with Chief Mason at that time. Tom said he would discuss with their Board and determine the situation or if any adjustments to their run card was needed. Tom was not aware of how the run card(s) work as a Board member of Jackson Township. The Board stated their concern for the residents of Jackson Township given the volume of runs in 2024 and year to date. Rushcreek Township Board members indicated their only concern was calling for assistance to remove trees from a Perry County Engineers Road. Tom expressed the same concern and had some discussion with the Perry County Engineers office. Both Tom and the Rushcreek Board agreed if needed we could attend either a Jackson or Rushcreek meeting to work on any further issues.

**Trustee Moyer** also stated the department is applying for the South Central Power grant at the next opening period. \$2800.00 for updated gear/ 60/40 split

Chief Duvall advised he had contacted the EPA after the recent storm and unauthorized burning and type of material being burnt which he observed. The EPA did send a letter directly to the resident involved in the violation.

Trustee Ashbaugh discussed with the Board about moving forward with both Hot and Cold Mix Scratch Coat of certain roads in order to continue to improve on the Chip Seal Process. He suggested putting out a bid request for 1.5 miles of Marietta Road from Bremen Village limit west to West Rushville Road. He also suggested we consider another road of similar traffic and length for Hot Mix Scratch Coat. Discussion between the Board and Richard, Road Supervisor about possible roads. They agreed a bid request for Hot Mix Scratch Coat would be published for 1.6 miles of Bethel Road to SR 312. The discussion also covered a solution for Heyd Road. 6/10 of a mile of Straight Paving. The Board agreed on a 3<sup>rd</sup> bid request for 6/10 of a mile for Straight Paving on Heyd Road. The bids will be put together and sent to the Board for approval with a bid date of May 7<sup>th</sup>.

#### **Administration**

Resolution 2025-09 Engineering Services was presented to the Board. Trustee Downard reviewed the resolution and indicated the culvert size(s) were not correct. In addition, Trustee Downard drove throughout the Township inspecting larger culverts. He found a culvert on Purvis Road that is also in need of repair. Another culvert on Purvis Road he was not able to inspect with the current volume of water. Additionally, he located a culvert on Ireland Road in need of replacement. Jim stated he would contact the County Engineer to review the culvert sizes on Resolution 2025-09 and ask if we should consider adding two more. The Resolution will allow the County to assist/apply for OPWC funds and provide the engineering for the project.

Drafted letter for Estep. The PA office has reviewed and made revisions to the proposed letter. Trustee Downard reviewed those adjustments with the PA office and is providing a copy of the letter to be sent to the Board for approval. Trustee Moyer will discuss the letter and the matter with the Zoning Inspector and provide her with the copy to send. Lisa Burnworth will forward any emails or documents she has to Lisa Criner.
