Trustee Ashbaugh discussed with the Board searching for a used 1 ton to 1.5 ton truck outfitted with a dump bed and plow as a second truck for this winter. He also discussed looking for a paver for patching roads. Also something used that can be choked down to 4 feet in width.

The Board agreed to search for these items.

Administration

Trustee Downard provided the Board with a draft letter regarding the Amanda Solar Project (Carnation). The Board reviewed the letter and approved the draft. Fiscal Office will email to Amanda and the Ohio Power Siting Board as well as send physical copy via USPS.

Trustee Downard discussed the culvert submitted to the County requiring replacement from the earlier passed Resolution. County Engineer Upp stated they would be submitted for OPWC grant in October.

He was not able to provide an update to Trustee Downard regarding the culvert work the County performed on Tent Church Road. Trustee Downard will contact Cheryl at the County Engineers office to obtain cost of the work.

Trustee Downard asked Richard to provide copies and format for submitting Force Account paperwork to the County for the emergency Zion Road culvert replacement.

Further Business:

Trustee Moyer did contact the PUCO regarding Young Road telephone pole and 664/County Line telephone pole (Frontier). Trustee Moyer was provided case#920130 by the PUCO. Richard stated the pole on Young Road had been replaced.

Trustee Moyer also met with Bruce Kelly regarding a rock from one of the mowers that struck a new garage door panel. Mr. Kelly stated the new door was recently installed by Woodside Door. Trustee Moyer will get an estimate on what the repair cost will be. The Board will review the estimate and determine whether to pay or file an insurance claim.
