# RUSHCREEK TOWNSHIP TRUSTEES MEETING MINUTES

# October 15, 2025

Chad Ashbaugh, Chairman called the Rushcreek Township Trustee Board meeting to order at 7:00 p.m.

Pledge to American Flag

#### **VISITORS**

Tim Thomas, Joe Lucas, Bill Myers-BZA, Charlie Hockman -RPC

Mr. Lucas had no items to address the Board, Mr. Thomas asked if there was a delay in mowing the Right of Way that many weeds have go to seed. Richard Campbell stated they had actually started earlier than normal and the Road Department was on vacation for a week. Trustee Ashbaugh indicated they are working on completing and there was a problem with a cylinder on the Arm Mower that was repaired while the Road staff was on Vacation. Mr. Thomas also inquired about the status of pheasant hunting business on Marietta Road. Why is the Township requesting conditional use permits for a business and does this not fall under Agritourism. Trustee Moyer indicated we are responding to at least 3 complaints from 2 surrounding neighbors and one business. Trustee Moyer indicated he has discussed with Leonard Ashcraft at ODNR and Zoning is responding to complaint letters received. Bill Myers- a BZA member also questioning the Zoning letter regarding Pheasant hunting. Trustee Downard explained we are gathering information and complaint letters and forwarding to the Proscecuting Attorney for direction to proceed. His research to this point which is not legal advice indicates that while the Pheasant hunting itself is not the problem that local rules governing nuisance, noise and peaceful enjoyment can possibly still apply. He also found that trap or skeet shooting is not Pheasant hunting and that nuisance and peaceful enjoyment impacting a long standing local business in Pumpkin Vine Golf Course have been impacted as stated in their complaint letter. Trustee Downard indicated the determination of the Township's role must be clarified by the Prosecuting Attorney's office. Charlie Hockman- RPC representative and BZA member along with Bill Myers stated the importance and having actual complaint letters from residents prior to pursing zoning complaints. Trustee Moyer indicated we have 3 at this time. Both Charlie and Bill indicated written complaints are important when pursing zoning matters. Bill indicated prior Board had an official complaint form that was used. Bill Myers added compliments for the Board and the Road Department in continuing to move the Township forward.

#### **Regional Planning**

Charlie Hockman reported RPC met on 10/7/2025 and one of the discussion items presented to RPC was changes to Berne Township's Zoning Resolution regarding Short Term Rentals (AIRBNB). Charlie related that Berne Township's proposed rules were very restrictive and have caused concern from some community. Commissioner Fix has met with Berne to address the concern. Charlie compared Rushcreek's updated short term rental policy to Berne's and is questioning why their Board wants to implement more restrictive policies and asked if any of our Board Members might be in communication with the Trustees' at Berne Township so we might have a better understanding or if there are specific reasons. Charlie related the RPC did not approve Berne's updated rules.
