WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructures, and

WHEREAS, the Board of Rushcreek Township Trustees is planning to make a capital improvement to various culverts in Rushcreek Township, and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF RUSHCREEK TOWNSHIP TRUSTEES, COUNTY OF FAIRFIELD, STATE OF OHIO:

SECTION 1: that the Chairman of this Board of Trustees is hereby authorized to apply to the OPWC for funds as described above.

SECTION 2: that the Chairman of this Board of Trustees is further authorized to enter into agreements as may be necessary and appropriate for obtaining this financial assistance.

SECTION 3: that this Board of Trustees accepts the Rushcreek Township Various Culvert Replacements Project as the Number One Priority for this Board of Township Trustees for the Round 40 Grant Application Year.

SECTION 4: that the Fiscal Officer of this Board of Township Trustees return a signed and certified copy of this Resolution to the County Engineer for further processing.


